Administrative Judge Roberts-Draper,

On January 26, 2023, you ordered the Postal Service to produce certain documents to Phase I Counsel for approximately 4,000 unidentified individuals. At that time, the Postal Service's document vendor was undergoing a site security review

and working to obtain clearance to operate. While the vendor has completed that review and is now operating, we will not be able to produce on February 23, 2023 the documents described in your January 26, 2023 Order and request an approximately two week extension—to March 10, 2023. We have met and conferred with Phase I Counsel, who does not oppose this request, provided that their May 8, 2023 deadline is moved to May 23, 2023. The Postal Service does not oppose Phase I Counsel’s request.
